The afternoon was an opportunity for Community groups to meet each other and share knowledge and experience of their Schemes. The representatives were also invited to visit the Area Incident Room to see how weather information is gathered and warnings are issued.

The task of choosing a flood protection product from the hundreds available has been made a little easier with the launch of the BSI Kitemarked flood protection products. These are products that have been independently tested and approved fit for purpose.

Although the Agency supports the scheme it does not endorse any individual product or manufacturer. It is the responsibility of the purchaser to ensure the products are appropriate for their property and correctly fitted.

Advice is also available from the National Flood Forum, an independent grassroots organisation which can offer support to those affected by flooding, possible sources of help and strategies for coping.
